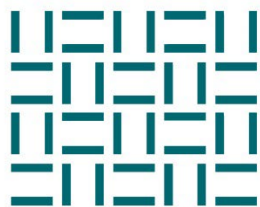

- Supporting the EURATEX Sustainable Businesses work in areas as: Circular Economy, chemical recycling, IED and other tasks as required

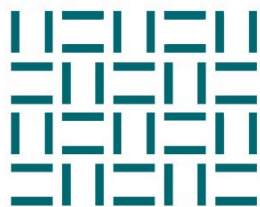
Education and experience
